

❖ **Transfer Services**

Forwarding of Remains to Another Funeral Home \$3400
This charge includes the removal of remains, basic services of funeral director and staff, recording vital statistics, securing permits and necessary authorizations, filing and obtaining death certificates and other forms and claims, embalming and preparation of the body, minimum shipping container and local transportation, but not shipping charges. This charge does not include visitation, rites and/or ceremonies prior to forwarding of the body.

Receiving of Remains from Another Funeral Home \$3130
This charge includes temporary shelter of remains, basic services of funeral director and staff, securing permits and authorizations, transportation of remains to funeral home and hearse to cemetery or crematory. This charge also includes rites and/or ceremonies at the cemetery.

❖ **Alternative Options for Disposition**

Direct Cremations From \$2885
The charge for a direct cremation includes removal of remains, local transportation to crematory, necessary authorizations, and basic services of staff. This charge does not include the crematory fee, cremation permit fee, or use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard boxes.

- Direct Cremation With Casket selected from our Funeral Home (in addition to cost of casket) \$2885
- Direct Cremation With Alternative Container selected from our Funeral Home \$3030
- Direct Cremation With Container Provided by Purchaser \$2885
- Stay to Close \$150
This charge is for the Director to be present (per Illinois requirement) for burial of cremated remains.

Immediate Burials From \$3035
The charge for immediate burial includes removal and shelter of remains, basic services of funeral director and staff, recording vital statistics, securing permits and necessary authorizations, filing and obtaining death certificates and other forms and claims, care of remains, local transportation to cemetery and "Stay to Close." This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial.

- Immediate Burial With Casket selected from our Funeral Home (in addition to cost of casket) \$3035
- Immediate Burial With Container Provided by Purchaser \$3035

Anatomical Gifts \$2885
This charge includes removal and shelter of remains, basic services of funeral director and staff, recording vital statistics, securing permits and necessary authorizations, filing and obtaining death certificates and other forms and claims, care of remains and transportation to the Anatomical Gift Association in Chicago. This charge does not include the cremation permit fee or any visitation, rites or ceremonies.

❖ Professional Services

Basic Services of Funeral Director and Staff \$2390

This charge includes but is not limited to, services of funeral director and staff to respond to initial request for service; arrangement conference with family or responsible person to determine services required; coordinating plans involved in the final disposition of the deceased; recording vital statistics; securing permits and authorizations; filing and obtaining death certificates and preparation of other forms and claims. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.) Included in this charge are overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

❖ Embalming

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

It is our policy to include embalming when ceremonies are selected which include a public viewing.
